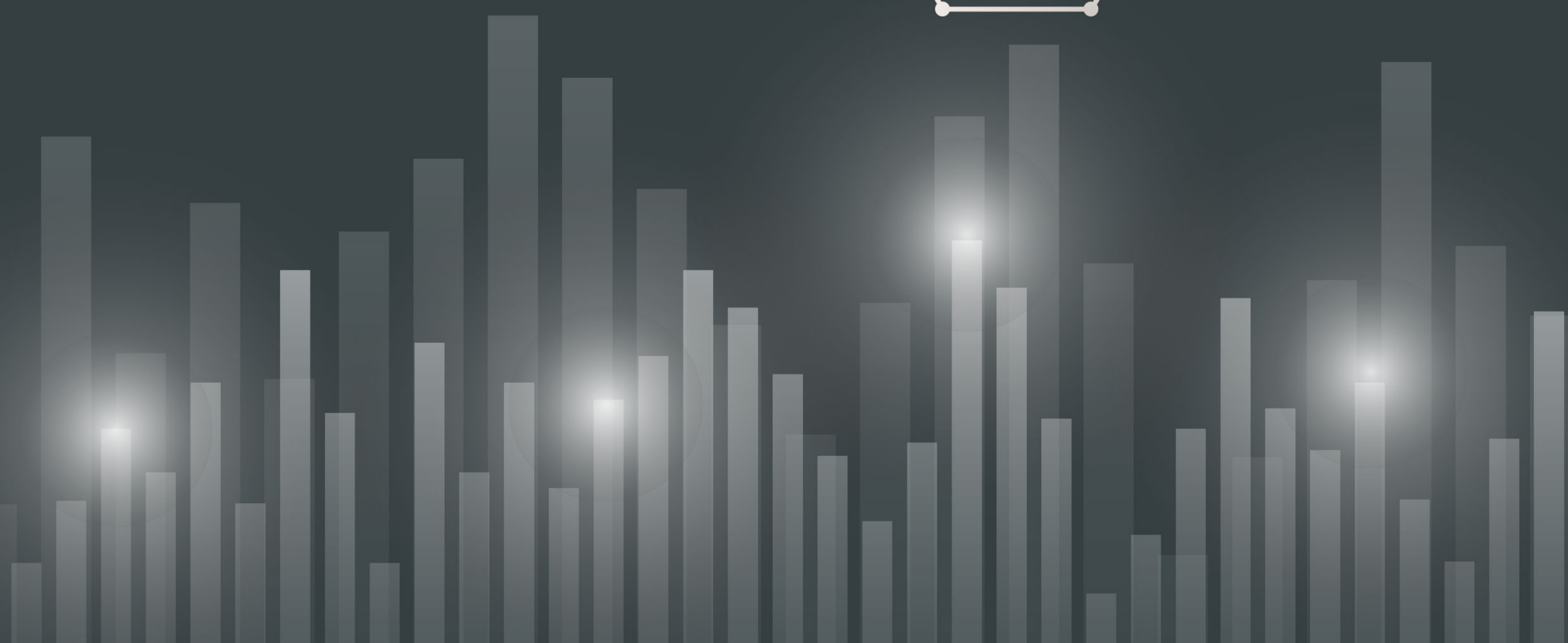


## Privacy Policy





# Privacy Policy

---

This Privacy Policy Notice (the “Notice”) describes how 1CLICK (“We”, “Our”, the “Company”) collects and processes your personal information through the 1CLICK websites and applications that reference this Privacy Policy Notice.

By using our services, you consent to the data practices described in this Notice and all extensions and addendums to this Notice.

## **The Controller of Your Personal Data**

1CLICK Limited is the data controller for personal information collected in connection with the provision of 1CLICK Services. Please feel free to contact us regarding any questions and regarding your rights relating to the processing of your personal data.

## **The Cookies and Other Identifiers**

1CLICK uses cookies and similar tools to improve your user experience, deliver our services, enhance our marketing efforts, and understand how customers use our services so we can make improvements. Depending on applicable laws in the region you are located in, the cookie banner on your browser will tell you how to accept or refuse cookies.

## **The Storage and Data Safety**

We developed our systems with your security and privacy as a premise. We have proper security measures in place to prevent your information from being accidentally lost, altered or disclosed, used, or accessed in an unapproved way.

We work to protect the security of your personal information during transmission and while stored by using encryption protocols and software. We keep physical, electronic, and procedural safeguards in connection with the collection, storage, and disclosure of your personal information. In addition, we limit access to your personal information to those employees, agents, contractors, and other third parties on a need-to-know basis.

## **How Long Does FunderPro Keep/Process Your Data**

We keep your personal information to allow your constant use of FunderPro Services, for as long as it is required in order to fulfill the relevant purposes described here, and as may be required by law such as for tax and accounting purposes, compliance with laws, or as otherwise communicated to you.

## **The data and the collection**

The data that was given to us by you as identification and contact data, specifically the name, surname, telephone number, e-mail, address, postal address, date of birth, username and password, and business identification number or tax registration number, if you are an entrepreneur; payment data, such as bank details; and other data, such as records of communication between you and our company or details of any warranty claims.



The data that was given to us by third parties, such as providers of trading platforms that you choose for use of our services, and social network operators if you decide to link your social networking accounts to an account on the website. As data about the simulated transactions, you have completed (such as the type of financial instrument, time of opening and closing the position, amount of investment, profit and loss) and data from social networks (user name, profile picture, e-mail address associated with the account on the social network).

As our current or past customers, we can from time to time send you marketing communications that relate to our services. We can also send you commercial communications to the extent to which you give us your consent. Each of the e-mails sent will be marked as a business communication and each of them will contain a link with the help of which you can easily unsubscribe from the business communications.

### **The purpose of to process**

To use the services, you must register on the website and create your account, and for this purpose, we process your personal data.

We also process your data related to the settings of your user account. We use your personal information to communicate with you in relation to our services.

We use your personal information to provide functionality, troubleshoot, analyze performance, fix errors, and the usability and effectiveness of 1CLICK Services.

### **The legal basis for our use of the data**

Processing is necessary for the performance of the contract, and the provision of these personal data is required, as we cannot register your user account without them. Also, the processing is necessary for the legitimate interest, after we stop providing you with services, we process personal information for a limited period. Such processing is necessary for the purposes of exercising and protecting our rights based on our legitimate interests.

Your consent when we ask for your consent to process your personal information for a specific purpose that we communicate to you. You may withdraw your consent at any time and we will stop processing your personal information for that purpose. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

### **The Data Sharing And Transfers To Third Countries**

To assist our operations, we may transfer your personal data to our Affiliates, service providers, and third-party partners. These parties include other companies in our group, hosting, and cloud service providers, payment system operators and financial institutions, providers of customer support tools and services, IT companies and system administrators, marketing and communication agencies, consultants, postal service providers, and others similar.

Also, we could transfer your data to persons regarding your consent to it, as well as in the cases where it is our responsibility under the law or under a judicial or any other legally binding decision. These entities are contractually obliged to protect your personal data in harmony with legal provisions and to process the data exclusively in accordance with our instructions.



### **The Rights That You Have**

You have several rights in relation to your privacy and the protection of your personal information. You have the right to request access to, correct, or delete your personal information, to ask for data portability, to object to our processing of your personal information, or ask that we restrict the processing of your personal information in certain instances.

In case when you consent to our processing of your personal information for a specified purpose, you can withdraw your consent at any time. If you want to exercise any of your rights please contact us at any time.

### **The Notices and Revisions**

If you have any concerns about privacy at 1CLICK, please contact us, and we will try to resolve them.

Our business changes regularly, and we may change this policy unilaterally, but we will do so only when necessary and we will notify you about such change.
